**PRIVACY NOTICE provided by
KTS ESTATE MANAGEMENT LIMITED**

This privacy notice explains what personal data (information) we hold about you, how we collect it, and how we use and may share information about you during our management of your leasehold/freehold property and after it ends. We are required to notify you of this information under the General Data Protection Regulation.

Please ensure you read this notice (sometimes referred to as a "privacy notice" and any other similar notice we may provide to you from time to time when we collect or process personal information about you. This privacy notice contains important information on who we are, how and why we collect, store, use and share personal information, your rights in relation to your personal information and how to contact us and supervisory authorities in the event you have a complaint.

1. WHO WE ARE

KTS Estate Management Limited collects, uses and is responsible for certain personal information about you. When we do so we are regulated under the General Data Protection Regulation which applies across the European Union (including in the United Kingdom) and we are responsible as 'controller' of that personal information for the purposes of those laws.

In this privacy notice, references to "we" or "us" means KTS Estate Management Limited.

2. DATA PROTECTION PRINCIPLES

We will comply with the data protection principles when gathering and using personal information, as set out in our GDPR data protection policy.

3. THE PERSONAL INFORMATION WE COLLECT AND USE: INFORMATION COLLECTED BY US

In the course of the performance of our contract as managing agent for the development where you are a resident, we collect the following personal information when you provide it to us:

- NAME, PROPERTY ADDRESS, HOME ADDRESS (IF DIFFERENT), HOME TELEPHONE NUMBER, WORK TELEPHONE NUMBER, MOBILE TELEPHONE NUMBER, EMAIL ADDRESS, IP ADDRESS, NOMINATED ALTERNATIVE CONTACT IN CASE OF EMERGENCIES
- MORTGAGE DETAILS, LAND REGISTRY, BANK DETAILS, BANK OR CREDIT CARD DETAILS
- CAR REGISTRATION NUMBER

The provision of your name, property address, home address (if different), home telephone number, work telephone number, mobile number, email address, IP address, mortgage details, Land Registry, car registration number, is required from you to enable us to perform our contract as managing agent appointed for and on behalf of your Freeholder/Management Company. We will inform you at the point of collecting information from you, whether you are required to provide the information to us.

4. **THE PERSONAL INFORMATION WE COLLECT AND USE: INFORMATION COLLECTED FROM OTHER SOURCES**

We may also obtain personal information from other sources as follows:

- Name, address, contact telephone numbers, email address from Solicitors, previous agents, estate agents, letting agents

5. **HOW WE USE YOUR PERSONAL INFORMATION**

We will typically collect and use this information for the following purposes:

- For the performance of a contract you have with our clients, your Freeholder/Management Company, and pursuant to which we are appointed as their agent.

and

- For the purposes of our legitimate interests or those of a third party, but only if these are not overridden by your interests, rights or freedoms.

We seek to ensure that our information collection and processing is always proportionate. We will notify you of any material changes to information we collect or to the purposes for which we collect and process it.

6. **WHO WE SHARE YOUR PERSONAL INFORMATION WITH**

We routinely share the following categories of personal data:

- Name, address, home telephone number, work telephone number, mobile telephone number, email address, car registration number, bank or credit card number

This personal information may be shared with the following categories of recipients:

- Contractors, Solicitors, Debt Collectors, Accountants, Auditors, Insurance Brokers, Insurance Companies, Loss Adjusters, Surveyors, Worldpay card payment scheme, Software Support, IT Support, Web Support, Parking Enforcement, Regulatory Authorities, Fire Authority, Local Authority, Ombudsman, Trade Bodies, Professional Organisations, Utility Companies, Letting Agents

We will not share your personal information with any other third party.

7. WHERE YOUR PERSONAL INFORMATION MAY BE HELD

Information may be held at our offices and those of our group companies, and third party agencies, service providers, representatives and agents as described above.

We have security measures in place to seek to ensure that there is appropriate security for information we hold including those measures detailed in our GDPR data protection policy.

8. HOW LONG YOUR PERSONAL INFORMATION WILL BE KEPT

We will hold:

- Name, property address, home address (if different), home telephone number, work telephone number, mobile telephone number, email addresses, IP address, mortgage details, land registry, car registration number, for 12 years after ending managing contract.
- Bank details and bank or credit card details for one week.

9. REASONS WE CAN COLLECT AND USE YOUR PERSONAL INFORMATION

We rely on Contract for the performance of the contract we have with our client and pursuant to which we are appointed as their agent and Legitimate Interests based on the obligations and covenants agreed between yourself and the Freeholder/Management Company in your Lease/Deeds. This Legitimate Interest requires us to be able to collect service charges and ground rent and carry out the maintenance and repair obligation outlined in the same document as the lawful bases on which we collect and use your personal data.

10. YOUR RIGHTS

Under the [General Data Protection Regulation](#) you have a number of important rights free of charge. In summary, those include rights to:

- fair processing of information and transparency over how we use your use personal information
- access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address
- require us to correct any mistakes in your information which we hold
- require the erasure of personal information concerning you in certain situations
- receive the personal information concerning you which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to a third party in certain situations
- object at any time to processing of personal information concerning you for direct marketing

- object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you
- object in certain other situations to our continued processing of your personal information
- otherwise restrict our processing of your personal information in certain circumstances
- claim compensation for damages caused by our breach of any data protection laws
